Adara USA is part of the global Adara Group (**Adara**) which is focussed on improving health and education for women, children and communities living in poverty. Adara are experts in maternal, newborn and child health (**MNCH**); and remote community development (**RCD**). Adara's work in MNCH makes a significant contribution to ending the preventable deaths of women, children and in particular, newborns. The programme work is primarily focussed at Kiwoko Hospital, Uganda. The healthcare provided at Kiwoko Hospital is considered a best-practice integrated MNCH service by global standards.

Adara undertakes RCD work in remote areas of Nepal including Humla and Ghyangfedi. Our RCD work involves improving local health services (including health awareness and improving nutrition, hygiene and sanitation), education initiatives (including building and expanding local school infrastructure, providing schoolteacher training and employment and vocational scholarships) and child safety and prevention of trafficking work.

With the experience and knowledge Adara has gained, through its MNCH and RCD work, we employ knowledge sharing tools to scale and share our insights to assist more people in low-resource settings worldwide.
